REQUEST FOR FURTHER INFORMATION

Thank you for your letter of 14 January 2009.

In reference to your request for advice as to the date on which the Company first "became aware" that the Cameroon Government had selected the Company's subsidiary, Cam Iron SA, to participate in the development of the iron ore terminal at the Port at Kribi, we respond as follows:

- (a) the concept of "becoming aware" involves making a judgement as to the reliability and certainty of the information received and the Company exercised its judgement in this matter in the following manner:
 - (i) an engineer working for our operating subsidiary in Cameroon received oral advice on 26 December that Cam Iron SA may be invited to participate in development of the deepwater port at Kribi and an indication that one of its competitors was not going to be permitted to participate. This was not considered sufficiently reliable information to make an announcement;
 - (ii) on Wednesday 7th January 2009, a draft press release in French was provided by the Government to Cam Iron SA who copied the release to the Company;
 - (iii) on Thursday 8th January 2009, Cam Iron SA had the draft press release translated and the Company reviewed the draft in English;
 - (iv) the Company decided that, although not material in nature, the matter merited an ASX release. The release was drafted on 13 January (the date on which we understood formal release would be printed in Cameroon);
 - (v) the formal Government announcement was published in the Cameroon Tribune on 14 January 2009.

We trust this answers your query. If you have any further queries relating to this matter, please do not hesitate to contact me.
